Purpose and legal basis of the processing

The purpose of processing this data is to analyse and monitor the activity of Users visiting our website in order to improve our communication and the structure of our website, as well as to create a profile of the User's interests in order to present relevant offers of our products and services also on other websites.

The legal basis for processing user personal data as described above is our legitimate interest.

What data do we collect using cookies?

We use cookie technology to collect only anonymous statistical data to improve the user experience when visiting our website. We do not collect any personally identifiable information about the User. The only information about the User that does not, however, allow the User to be identified, is the IP address from which the User connects.

Your IP address may also be shared with our partners, including Google. However, also in this case, it is not possible to identify the User on the basis of this data.

What do we use cookies for?

We use the following cookies on our website:

- analytical - we use analytical cookies to improve the functioning of our website and to measure, without identifying your personal data, the effectiveness of our marketing activities;
- functional cookies - functional cookies enable remembering the User's selected settings and personalizing the User's interface, e.g. with regard to the selected language or region from which the User comes from, website layout, font size etc.

How long do we use cookies?

We use two types of cookies:

- session cookies - saved on the User's device until leaving the website or closing the web browser;
- persistent cookies - stored on the User's device for a specified period of time or until they are manually erased.

Can a user opt out of accepting cookies?

By default, web browsers allow the storage of cookies. However, if a User wishes to restrict or block cookies, it is always possible to do so via the browser settings on the computer.

However, it should be remembered that changing the settings in the browser may result in the loss of the possibility of using certain functionalities available on our website.
